


Patients tell us that these organisations are instructing clients to request a letter of support from their GP. If an organisation requires medical information in order to decide on the appropriate decision for a claim or other situation it is the responsibility of that organisation to formally request a report giving patient consent to release the information. From now on if you ask for such a letter at an appointment or at reception you will be given an information sheet stating this. Please note there will be a charge made for letters of support
